Regulations on Use of Campus Space

1. Preamble

The University endeavours to maintain befitting and effective use of campus space for staff members and students. This set of Regulations (Regulations) is aimed at providing a systematic approach to managing the use of campus space in conformity with the University's vision and mission. The University upholds the rights to freedom of expression and equal opportunities and requires that the exercise of these rights should not infringe on the rights of others.

2. Definition

Campus spaces shall include the following:

- 2.1 Spaces of departments/offices/units refer to the allocated or temporarily allocated spaces to respective departments/offices/units through the space allocation mechanism.
- 2.2 University-wide spaces refer to central spaces designated for teaching, learning, research and amenity use. The current managing agents of all University-wide spaces are listed in Appendix 1.
- 2.3 Common areas refer to spaces that have not been assigned for a specific purpose and are intended for common enjoyment of the University community as a whole besides being the general means of access. The common areas include but are not limited to podiums, plazas, courtyards, gardens, entrances of campuses, lobbies, corridors and staircases of buildings on campus.

3. General principles

- 3.1 All campus spaces should be used according to their assigned purposes. Change of the assigned use is not allowed except with prior approval by the University.
- 3.2 Application for temporary use of campus spaces shall follow the prevailing reservation procedures, terms and conditions as formulated by the respective responsible departments/offices/units.
- 3.3 The use of campus spaces should not:
 - (a) contravene any Hong Kong law;

- (b) contravene any of the University's prevailing policies, regulations and rules;
- (c) contravene any health and safety regulations of the University;
- (d) cause any inconvenience, nuisance or potential danger to other users; and
- (e) cause any damage to the property of the University.
- 3.4 No commercial activity is permitted in any campus spaces except with prior approval by the University.
- 3.5 Academic and administrative units, staff members, student organisations and students using the campus spaces are responsible and accountable for the cleanliness and order of the campus spaces during their use and shall ensure proper compliance with the Regulations.
- 3.6 Unauthorised use of campus spaces by any persons (including staff members, students, invitees and/or the general public) is strictly prohibited.
- 3.7 The use of campus spaces should be in line with the University policy or directions on a low-carbon campus. Reduction in carbon footprint through measures and practices of reducing, reusing and recycling in campus spaces should be accorded the top priority.
- 3.8 The University reserves the right to terminate, suspend temporarily or refuse any use of campus spaces that fails to comply with the Regulations.

4. Responsible persons

- 4.1 Academic and administrative units may issue guidelines in relation to the use of campus spaces managed by them. Such guidelines should be consistent with the principles of the Regulations.
- 4.2 The Heads/Directors of departments/offices/units or their delegates shall implement the Regulations and/or the guidelines and shall bear primary responsibility to take immediate action in the case of any improper use of campus spaces or breach of the Regulations and/or the guidelines within the areas managed by them in their respective departments/offices/units.
- 4.3 The Directors of respective managing agents or their delegates shall implement the Regulations and/or the guidelines in their managed areas of University-wide teaching, learning, research and amenity spaces and shall bear primary responsibility to take immediate action in the case of any improper use of campus spaces or breach of the Regulations and/or the guidelines within the areas managed by them.

- 4.4 The Director of Estates or his/her delegate shall implement the Regulations and/or the guidelines and shall bear primary responsibility to take immediate action in the case of any improper use of campus spaces or breach of the Regulations and/or the guidelines in all common areas of the University.
- 4.5 The Heads/Directors of departments/offices/units or their delegates shall take necessary follow-up actions on the staff member(s) of the respective departments/offices/units involved in the case of any improper use of campus spaces or breach of the Regulations and/or the guidelines.
- 4.6 The Director of Student Affairs, the Director of College of International Education, the School of Continuing Education or his/her delegate shall take necessary follow-up actions on the student organisation(s) and/or the student(s) involved in the case of any improper use of campus spaces or breach of the guidelines and/or the Regulations.
- 4.7 The Director of Estates or his/her delegate shall take necessary follow-up actions in respect of all matters relating to the improper use of campus spaces by anyone other than those mentioned in paragraphs 4.5 and 4.6 above.
- 4.8 Depending on the circumstances, any improper use of campus spaces should be reported to supervising Dean or Vice-President or the risk management group, as appropriate, for further directions.

5. Delegation of authority by the University Administration

- 5.1 The Vice-President (Administration) and Secretary has the overall responsibility and final discretion in respect of the implementation and administration of the Regulations.
- 5.2 The Estates Office (EO) is authorised to publish the Regulations and act in accordance with the provisions in the Regulations.

6. Review

6.1 The Regulations may be reviewed by EO annually or as and when required.
