Reason why a new MPF service provider is added and the selection/evaluation process

Why there is a change?

As a continuous effort to ensure the delivery of our retirement benefit is competitive, cost-effective, and compliant with legislation, the University has appointed an external independent consultant, Mercer, to conduct a comprehensive review of the HKBU's existing MPF service provider.

After reviewed Invesco, we found that Invesco lagging behind its peers in the following areas:

- Fund Choice Invesco has a relatively narrower fund range than its peers
- **Fund Performance** Decline in overall Fund performance since 2020
- Service Unavailability of electronic channels and absence of mobile application

<u>Therefore</u>, we recommended HKBU to add a new service provider to complement Invesco.

Selection / evaluation process – Step 1

Screening Criteria (aim to complement Invesco):

- Fund Choice covers 14 or more asset classes
- Strong historical performance (outperformed peer group median on both an absolute return and risk-adjusted basis in long term)
- Better administrative servicing (e.g. Mobile Apps)
- Larger market share

Selection / evaluation process – Step 2

For the MPF providers who are generally able to satisfy all the selection criteria, we compared the following areas of each scheme:

- Financial stability and reputation;
- Investment performance;
- Fund management fees;
- Fund choices; and
- Fund administration services.

There are 3 providers that outperform the rest of the market in each of above areas:

AIA Manulife Sun Life

Staff Affairs Committee (SAC) & Human Resources Committee (HRC) conducted interviews with each of the 3 shortlisted providers.

Selection / evaluation process – Step 3

After interviewing and summarizing the performance of the shortlisted providers, **Sun Life** was appointed as the new service provider.

The table below summarises Sun Life's ranking among the 3 shortlisted schemes on the assessment criteria.


Your choice of MPF providers

- Upon reviewing MPF providers in the market, HKBU has added Sun Life as addition MPF provider.
- Effective date: 1 Nov 2023

Your choice:

- i. Stay in existing MPF scheme: Invesco Strategic MPF Scheme ("Invesco MPF"); OR
- ii. Transfer to New MPF scheme: Sun Life Rainbow MPF Scheme ("Sun Life MPF")

Once you choose your MPF scheme, your <u>future monthly contributions and the accrued benefits</u> will be invested with your selected MPF scheme.



If you choose to transfer to new MPF provider

- Effective date: 1 Nov 2023
- Starting from the month of Nov 2023, **future contributions** will be made to Sun Life MPF and **accrued benefits** will be transferred to Sun Life MPF.


Out-of-market Risk

- Transferring accrued benefits to another MPF scheme involves buying and selling fund units.
- After the trustee of the original scheme has redeemed the funds and before the trustee of the new scheme
 has subscribed to new funds, there is generally a time-lag of about 15 16 working days (the length of
 the period depends on the actual situation), during which the scheme member's accrued benefits will not be
 invested in any fund. Since fund prices may change due to market fluctuations during this period, there is a
 chance of "selling low, buying high" or vice versa. This is the out-of-market risk.

Change of MPF provider


Transfer timeline



- No additional charge for scheme transfer
- You should receive a transfer-out statement from the current MPF provider stating how much has been transferred.
- You should receive a transfer-in statement from the new MPF provider stating how much has been received. The amount should be the same as the transferred-out amount.


